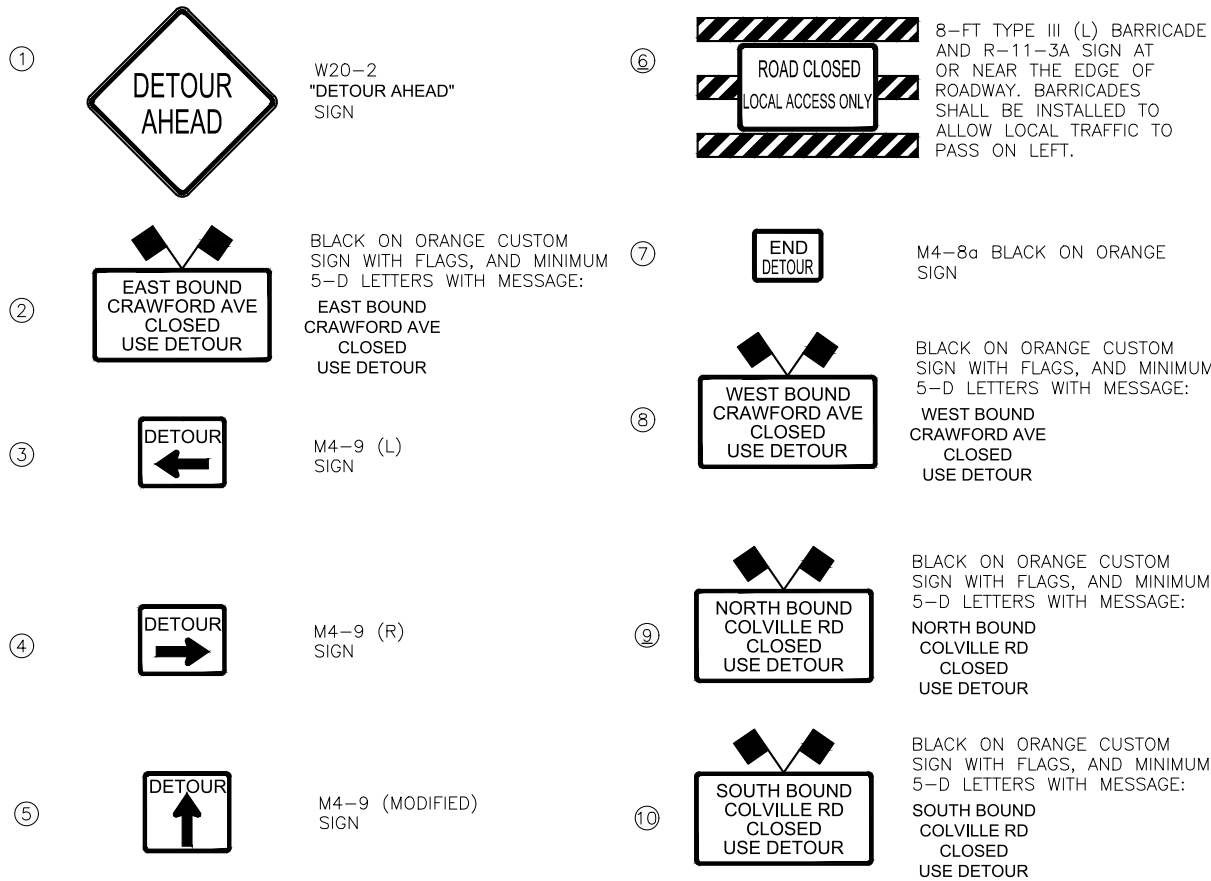


TRAFFIC CONTROL NOTES:

1. THE CONTRACTOR SHALL ADJUST CHANNELIZATION DEVICES AS NEEDED TO SUIT TRAFFIC AND VISIBILITY CONDITIONS. LAYOUT TO BE APPROVED BY THE PROJECT ENGINEER. SIGNS SHOWN ARE AN ESTIMATE ONLY. ADDITIONAL SIGNS MAY BE NECESSARY.
2. ALL SIGNS WITHIN THE WORK AREA SHALL BE IN ACCORDANCE WITH W.S.D.O.T. STANDARD PLANS AND THE MUTCD.
3. THE CONTRACTOR SHALL ENSURE AT LEAST ONE ACCESS DRIVE TO ALL PUBLIC AND PRIVATE PROPERTIES IS KEPT OPEN TO TRAFFIC AT ALL TIMES EXCEPT WITH WRITTEN APPROVAL FROM THE CITY.
4. THE CONTRACTOR SHALL BE RESPONSIBLE FOR PROVIDING BARRIERS AS NEEDED TO PROTECT CONSTRUCTION WORKERS AND PEDESTRIANS FROM VEHICULAR TRAFFIC AND CONSTRUCTION EQUIPMENT AND CONDITIONS.
5. ALL CLASS A CONSTRUCTION SIGNS SHALL BE MOUNTED ON A SINGLE 4"x4" WOOD POST UNLESS OTHERWISE NOTED OR APPROVED BY THE CITY OF DEER PARK.
6. THE CONTRACTOR SHALL COORDINATE WITH EMERGENCY SERVICES.

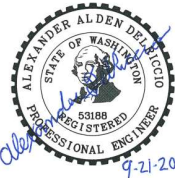
