Code Of Conduct

Be *polite* and respectful of others, show courtesy to locals, Tournament Staff, Tournament Participants, and Animals located on the Tournament Grounds.

Meddling with or stealing vendor stock, Tournament equipment, or staff belongings will not be tolerated and violators will be prosecuted to the fullest extent of the Law.

Potential harassment, Sexual or otherwise will not be tolerated. In the State of Washington ANY behavior that makes one feel threatened or uncomfortable is harassment. Such behavior at this tournament will not be tolerated. Legal action will be taken and the Vendor, Patron, or Staff member will not be allowed back into the Tournament or onto the rodeo grounds.

Please Ask for help and Tell Tournament tournament staff about any potential harassment.

Illegal possession of a controlled substance will result in the contact of law enforcement and ejection from the tournament grounds.

Alcohol may not be consumed by participants before any tournament events they are participating in.

Alcohol will not be sold or in any way provided to minors on the site. Anyone involved in providing a minor with alcohol will be removed from the grounds and may be prosecuted.

If you are not an equestrian participant please do not touch any horses or equestrian equipment without the knowledge and consent of the owners.
